I hereby declare and warrant that I am duly authorised to give this declaration for and on behalf of the persons nominating this horse.

3 **Nominator - entity ABN and/or registered for GST**

Categories

1. Hobby Nomination Declaration

If the nominator(s) of a horse are not registered for GST, then the bonus payment will be made exclusive of GST to the nominator of the horse. Where the nominator(s) are hobbyists category (1) must be ticked. Each nominator must be listed and the appropriate areas filled out on the form for each owner. Each nominator must sign and the managing nominator must sign for the form to be complete.

2. Nomination - Part ABN and/or GST registered and Part Hobby Declaration

If a horse is co-nominated in an arrangement that comprises both ABN and/or GST registered nominators, and hobby nominators where the combination of nominators does not constitute an entity, both category (1) and (2) must be ticked. The completion of the rest of the form detailing the ABN and/or GST registered nominator(s) and the hobby nominator(s) status for GST, will ensure that the correct amount of GST is paid on bonuses.

3. Nomination - Entity Registered for GST Declaration

If the nominator(s) of a horse are registered for an ABN and/or GST you will need to provide your ABN to the Registrar of Racehorses. Racing Victoria Limited will pay the bonus inclusive of GST to the nominator(s) where the nominator is both registered for an ABN and GST. It will then be the responsibility of the manager or nominated person to report the GST component of the bonus in the relevant Business Activity Statement where the nominator is registered for GST.
